2.4 Issues and Opportunities arising from the Evidence Base

Section 2 Community Facilities and Green Infrastructure

2.1 Policy Overview

2.1.1 National Planning Policy Framework

Key messages from the NPPF include:

- The social role of the planning system involves 'supporting vibrant and healthy communities'.
- The planning system can play an important role in facilitating social interaction and creating healthy, inclusive communities.
- Promote the retention and development of local services and community facilities such as local shops, meeting places, sports venues, cultural buildings, public houses and places of worship.
- Ensure that developments create safe and accessible environments where crime and disorder and the fear of crime do not undermine quality of life or community cohesion. Places should contain clear and legible pedestrian routes and high quality public spaces which encourage the active and continual use of public areas.
- Ensuring there is 'sufficient choice of school places' is 'of great importance' and there is a need to take a proactive, positive and collaborative approach to bringing forward development which will widen choice in education.
- High quality open spaces should be protected or their loss mitigated, unless a lack of need is established.
- Adopt proactive strategies to adapt and manage risks through measures including green infrastructure i.e. a network of multifuntional greenspace, urban and rural, which is capable of delivering a wide range of environmental and quality of life benefits for local communities.

2.1.2 Cornwall Local Plan

Key messages from the Cornwall Local Plan include:

- To reduce poverty and social exclusion and provide opportunities for all to participate fully in society.
- To improve health through improving access to open space and health, recreation and sports facilities.
- To improve access to key services and facilities by reducing the need to travel and by providing safe, sustainable travel choices.
- Open Space and Green Infrastructure can play an important role in improving health and wellbeing by providing accessible space for recreation.
- Green Infrastructure networks should be enhanced through the maintenance and improvement of strategic green corridors, provision of enhanced walking and cycling routes and enhancement to ecological networks.

According to the Cornwall Local Plan – Strategic Policies 2010-2030 the definition of community facilities is wide-ranging and includes:

- public services, community centres and public halls
- arts and cultural facilities
- policing, fire and ambulance services
- health and education facilities
- public houses, public toilets, youth centres, nurseries and libraries
- leisure centres, allotments and playing fields
- social care facilities including day centres
- places of worship and services provided by the community and voluntary sector

2.1.3 Other plans and studies

Dobwalls and Trewidland Parish Plan 2005 - Community Visions

- Thriving post offices, shops and other amenities
- A wide range of services provided locally through the use of community buildings that are adequately heated, maintained and equipped for multi-use purposes
- Sensitivity to the needs of those with disabilities
- An annual fun event to bring the community together
- Appropriate play grounds, well equipped and adequately maintained
- Appropriate support and facilities (such a skateboarding areas) available for the young people of the plan area
- Access to a wide range of social activities and events for all members of the community
- Access to library services for all members of the community
- Clear and appropriate postal addresses

Natural England 'Green Infrastructure Guidance'

Green Infrastructure is a network of natural and semi-natural features, green spaces, rivers and lakes that intersperse and connect villages, towns and cities. Green Infrastructure Assets range from country parks, lakes and woodlands to urban interventions such as green roofs and street trees. They can be specific sites at the local level or broader environmental features at the landscape scale within and between rural and urban areas. By creating a network of multi-functioning Green Infrastructure a wide range of environmental and quality of life benefits for local communities can be delivered.

Natural England's 'Green Infrastructure Guidance' defines Green Infrastructure as:

"Green Infrastructure is a strategically planned and delivered network comprising the broadest range of high quality green spaces and other environmental features. It should be designed and managed as a multifunctional resource capable of delivering those ecological services and quality of life benefits required by the communities it services and needed to underpin sustainability. Its design and management should also respect and enhance the character and distinctiveness of an area with regard to habitats and landscape types. Green Infrastructure includes established green spaces and new sites and should thread through and surround the built environment and connect the urban area to its wider rural hinterland. Consequently, it needs to be delivered at all spatial scales from sub-regional to local neighbourhood levels, accommodating both accessible natural green spaces within local communities and often much larger sites in the urban fringe and wider countryside."

A Green Infrastructure Strategy for Cornwall

The Green Infrastructure Strategy for Cornwall provides a single point of reference, enabling a strategic framework to be developed to achieve the vision of – "a strategically planned and delivered green network throughout Cornwall, comprising high quality green spaces, green corridors and other environmental features delivering a wide range of ecosystem services for the benefit of all." The strategy provides key themes, priorities, related outcomes and key actions as well as key partners. Themes include health and wellbeing, economy, climate change, education and environmental quality.

There are two key initiatives proposed in this strategy as a means of securing and maximising the opportunities for planning and delivering Green Infrastructure for Cornwall as follows:

Green Infrastructure in Growth Areas: Green Infrastructure strategies being developed at a Town Framework level for larger settlements. Key information for such framework level strategies will consist of flooding and surface water areas, ecological resources, active travel and connections and public open spaces.

Green Infrastructure in Rural Areas: Cornwall Council is undertaking a further piece of work based on the Town Framework areas, whereby a selection of 108 smaller settlements that are likely to see some level of growth over the next 20 years will be identified for rural assessments. As an additional benefit taken together, the evidence base and associated information will enable Cornwall Council to set its own locally relevant public open space standards.

Cornwall Council will support and provide technical guidance to parish and town councils working on developing Neighbourhood Development Plans. Work will be required to develop a template and guidance to ensure that Green Infrastructure planning is integrated into the plan-making process.

The differences in populations of the two areas of Dobwalls and Trewidland mean that there are very different service provisions for each of the areas.

The D&T NDP area does not have a doctors' surgery. The nearest health services are in Liskeard – at Rosedean Surgery and Oak Tree Surgery. Both these surgeries have full daily services and are supported by clinics.

Liskeard also provides dentists at The Smile Centre, Windsor Place Dentist (now known as Bupa Dental Care) and Liskeard Dental Centre.

The following community facilities, services and amenities serve the plan area. Because of the physical distances between the Dobwalls and Trewidland areas, these are covered in relation to each of the two villages in turn.

Dobwalls Primary School is situated on the southern edge of the village. At 1 st March 2022 it had a roll of 180 children. There is a nursery situated next to the school. Local secondary school provision is at Liskeard School and Community College and children are supported by a school bus from and to the centre of the village each school day.
Dobwalls United Church provides weekly church services and its hall provides a very useful base for many additional activities, including a Ladies Group, Toddler Group and Knit and Knatter.

The Highwayman public house, located to the south of the main street through the village provides meals, refreshment, quiz nights and live music nights and supports the annual charity beer and cider festival.
The Spar on Duloe Road, near the centre of the village, provides food shopping and an off licence in addition to the village Post Office.
Dreckly Hair and Beauty (formerly Heads or Tales village shop). Hairdressers situated in the centre of the main street.
The Antiques Shop , to the west end of the main street, also provides a kitchen furniture design and construction service.
Rowes Garage is situated towards the end of the main street in an area known as Five Lanes. It provides MOT and car repairs as well as a car showroom for new and used cars.
Dobwalls Football Club is a well-established football club with five junior and two adult teams. The first team play in the South West Peninsula League and the second team play in Cornwall's Duchy League. The junior teams cater for various age groups. The club has two full size pitches and a clubhouse with a bar. The clubhouse is the venue for Dobwalls Parish Council meetings. The parish council has also purchased the field next to the Dobwalls Jubilee Community Field and this is being developed and co-ordinated by the trustees of the club.
Dobwalls Snooker Club , on the main street, has two full-sized snooker tables plus a meeting, cards and darts room. The club is used by both male and female members of any age to play snooker and billiards.
Dobwalls Jubilee Community Field is a new open space area on the edge of the village to be used and enjoyed by the community and future generations. The field, an ambitious parish council initiative, has 1,300 newly-planted trees, raised areas planted with shrubs, an orchard, seeded wildflower area and benches and picnic tables.



Trewidland Village Hall Hall and kitchen Car parking capacity approximately 15 Disabled access
 Trewidland Primary School, on the valley lane to the north of Trewidland Village, serves the communities of Trewidland and St Keyne. It has a current roll of 29 children, with five in the Preschool Group. Trenode Church of England Primary School is also attended by some local children. Secondary Schools at Liskeard and Looe are attended by local children. However, the school bus service from the village only serves Liskeard School, with access to the other school only available from the Looe road at Horningtops, to the east of the area.
Trewidland Shop, in the centre of the village, was closed in 2007 and is currently used as a display area for the Trewidland Local History Group material. The phone box shown in the photo above has subsequently been removed by British Telecom.
Trewidland Snooker Club, housed in what was the Village Reading Room, has a full-sized snooker table available for use by all club members.

2.2.4 Green Infrastructure Assets Public Footpaths

The geography of the plan area is such that the roughly triangular areas around Dobwalls and Trewidland are linked by a short stretch of the East Looe River, to the south of Liskeard. Each of the major areas has a network of footpaths. Some of these are officially designated and classified for maintenance by contractors employed by Dobwalls Parish Council and St Keyne and Trewidland Parish Council.

Lanes and Bridleways

Local lanes, which typically have light traffic, are key local assets for pedestrians, cyclists and horse riders. There are no official bridleways in the plan area.

There are no routes between the Dobwalls and Trewidland areas which do not pass through neighbouring parishes i.e.:

- The lane from Trewidland through St Keyne and Trewidland Parish which links to the Duloe road (in Duloe parish) and hence to Dobwalls.
- The lane from Trewidland to Liskeard which goes through Liskeard west at Moorswater and then on to Dobwalls.
- The lane from Trewidland to Horningtops, which then joins the Liskeard to Looe road and the A38.

The separate/differing nature of the two areas means that the infrastructure of each area is dealt with separately below.

Dobwalls Public Footpaths



The table below identifies each of the currently used footpaths in the Dobwalls area and gives the Cornwall Council code, designation, current condition and responsibility for maintenance of each route. This section of the plan area also includes a short section of the Caradon Multi Use Trail.

Of particular value is the linear connection which allows access from the Highwayman car park through to "The Green" to the south of the village.




Dobwalls Children's Play Areas and public Open Space

The plan above shows the location of existing and proposed play areas in Dobwalls village. Few are aware of the play area site behind Pendray Gardens. Issues have also been raised about the provision of seating (for both children and parents) in or near play areas and of the suitability of access which is up steps to the Rowe Court playground.

Unfortunately, there is no comparable map for play areas in either Doublebois or Trewidland. At present local children in these villages have no designated play space.

A more detailed Open Space Survey was carried out in 2020 with the assistance of Cornwall Council Landscape officer Stuart Wallace (see page 19).



2.2.5 Open Space Survey

In the Spring of 2020 Stuart Wallace, of Cornwall Council, undertook a survey of the open space provision in the Dobwalls, Trewidland and Doublebois settlements.



The results below were analysed against national standards which indicated that there is a shortfall in provision of Open Space in Dobwalls and that in Doublebois and Trewidland there is no public open space.

In October 2020 a short questionnaire was sent out to 40 local households spread across all three areas and the resulting responses identified issues that were of particular concern to local people.

Further questions were also included in the January 2021 D&T NDP newsletter to provide greater detail.

2.2.6 Green Infrastructure Strategy

Green Infrastructure Strategic Objectives

Significant importance was given during the Dobwalls and Trewidland Neighbourhood Development Plan consultation process (2017-2021) to the role of Open Space, Greenspace and Public Rights of Way in the high value that local people put on the sense of place in their home areas. The need for Public Open Space to support health, community integration and biodiversity objectives was clearly apparent and encouraged the plan steering group to develop this Open Space/Green Infrastructure Strategy. The benefits of Green Infrastructure were recognised in the D&T NDP policy area objectives and were explored in detail in the Green Infrastructure Strategy document.

Green Infrastructure Summary (2021)

The NDP process, including the following evidence bases, identified a range of important and highly-valued resources provided in the local environments of both the Dobwalls/Doublebois area and of the Trewidland area. It also identified significant gaps in the provision of adequate Green Infrastructure resources to meet the needs of each of the local communities.

It was seen as essential to assess and document in each of the major areas covered by the plan the current provision and adequacy of:

- Existing public open space which needs to be maintained and enhanced.
- Ensure that particularly valued open spaces are safeguarded from future inappropriate development through Green Space designation where required.
- Explore the improvements that could be made through reinforcing and reopening Public Rights of Way.

Existing footpaths and PRoW can link and give access to other informal Green Infrastructure resources seen as creating significant benefits for both local and visiting individuals, the social and physical health of the community and the health and diversity of the natural and historic environment of the plan area.

Proposed enhancement of Greenspace should be delivered through a co-ordinated Green Infrastructure approach, including input from Cornwall Council, Natural England and local organisations.

It is recognised that with the difficulties that have resulted from the Covid-19 pandemic it has been hard to make significant progress with detailed consultations on the future shape of open space proposals within any of the villages.

However, we have reached a point where we have a clear, logical basis for future decisionmaking when the circumstances allow us to engage in more detail with local people in each part of the plan area.

2.3 Community Consultation Feedback

A series of public consultations on the D&T NDP has taken place throughout the NDP process. The following draws together the information on Community Facilities and Greenspace and related issues at each stage of this consultation process.

2.3.1 Responses to Initial Questionnaire March 2017

The analysis of the Initial Questionnaire allowed us to rank the key importance of a range of issues to those who responded, based on the number of 'agree' ticks.


2.3.2 Responses to Second Questionnaire May 2018

Q3 Preservation of Greenspace





'Looking ahead, which of the following do you think would be most important to you? Please tick your top three only: (%)'




Q4 Community safety, health and wellbeing. Please rate the importance of the following:




Q10 Do you have children of school age?


The recent Open Space assessment carried out by Stuart Wallace (Cornwall Council officer) and the 'Dobwalls and Trewidland Open Space Survey' is intended to give us a much clearer picture of how local people in each of the areas would like to see appropriate open space being developed, improved or created to meet the needs of all members of the community.

Policy: Community Facilities and Open Space

CF1: To protect and promote community facilities, development proposals should retain, promote and enhance essential community facilities, village halts, public toilets, post offices, schools, green spaces and car parking. The loss of community and cultural assets will be resisted unless replacements of better value are provided at an agreed location.

CF2: Development of community health and cultural facilities and services in sustainable locations (e.g. Health clinic facilities, allocments, play parks, fitness trails, extensions to cycle trails and sporting facilities, etc.) will be supported.

CF3: Facilities to meet the needs of all sectors of the community. Developments should provide continuous even surfaces and kerbs for pedestrians and wheeled users to aid safe mobility around the parish.

- Improvements to existing areas need discussion with local residents/landowners.
- Footpaths need maintenance and re-opening.
- Facilities for children and teenagers.
- New Public Open Space for Trewidland.

2.4 Key Issues and Opportunities for Dobwalls and Trewidland

2.4.1 Issues

Community Facilities

- Although Dobwalls and Trewidland appear to be independent areas, many of the issues in the rural areas of Dobwalls have much in common with the rural area of Trewidland.
- Many of the existing community activities are dependent on the Trewidland Village Hall and Dobwalls Memorial Hall. Both these buildings are currently in a poor state of repair, despite the efforts of their respective management committees, and are in need of financial investments which are not easily achieved. Update June 2022, both buildings have had investment since this comment was made.
- Dobwalls is very well served in terms of facilities/shops and community activities within the local area, many within walking distance in the main village. The regular bus services to Liskeard and Bodmin etc. provide access to medical and other facilities not available in the village.
- However, in Trewidland, the lack of a local shop and post office coupled with the absence
 of public transport for the area means that all major services have to be accessed by
 private car. This is likely to become increasingly problematic as the population of the plan
 area ages.
- The lack of access to medical services in the villages is seen as a significant issue in relation to the age.
- The lack of provision of either activities or space for young people, particularly in Trewidland, is a concern for many families.

Footpaths

- There is a need for a review of the current classification of footpaths in the plan area to identify what local people using these resources consider to be the most significant routes, and to reflect this in the classification of the footpaths for maintenance.
- Clear large scale Footpath maps (A2) of each of the areas, identifying the status of the paths would assist both local people and visitors/tourists in making full use of the footpath system.
- There are some cases where existing footpaths are blocked/inaccessible.
- Identification of potential 'round trip' walking routes would encourage wider use of the existing resources in both areas.

Green Infrastructure/Open Space

- Provision of play areas in Dobwalls is inadequate or not appropriate for different age groups, and in Trewidland and Doublebois does not exist.
- The management of the graveyards in the two villages are treated differently. Are there opportunities to increase the biodiversity of these areas, while maintaining appropriate standards of management?

2.4.2 Opportunities

Community Facilities

- There is recognition of the need for investment in both Village Halls to ensure that they can continue to provide appropriate facilities for the many local groups and activities which are dependent on the space and facilities that they provide. **Update June 2022**, both buildings have had investment since this comment was made.
- There is support for the creation (in Trewidland) and the upgrading (in Dobwalls) of a central public open space which could provide a resource for outdoor events summer fetes/etc.
- The recently constituted Trewidland Community Group has proved successful in initiating and supporting a variety of activities in the NDP area.

Footpaths

- Problems of car parking at peak times for both local schools emphasise the need for a review of all walking routes to each school, (including those from St Keyne to Trewidland School) and the potential to upgrade these routes to encourage walking to school.
- The importance of maintaining access or in some cases recreating access to all Public Rights of Way across the parish is seen as vital to support walkers and visitors to the area.

Green Infrastructure/Open Space

- The provision of benches in both green spaces and play areas in the Dobwalls area, and in e.g., the graveyard and related to existing footpaths, could encourage use of these areas by both older and younger members of the community improving health and social interaction.
- The provision of 'outdoor Gym' equipment particularly in the Dobwalls green spaces could provide a community resource which would support exercise and health.
- The protection of significant groups of trees in both areas could ensure that these important visual and biodiversity benefits are maintained.
- Could the introduction of ponds/wetland areas where suitable also enhance the local wildlife?

The need for the development of an integrated Green Infrastructure Strategy for the NDP area is seen as an important outcome from the NDP process.

Update – March 2022

Dobwalls Parish Council has been fortunate to purchase a field which is currently being landscaped into a Community Open Space and Forest for the local community to enjoy for the future and further generations to come. At the time of writing, over 1300 trees have been planted including a small memorial area where people who have lost loved ones can place a plaque in front of a tree. The orchard has been started and plans are in hand to have a wildflower meadow created. The remaining area will provide somewhere for people to sit and relax or to watch their children play and could also be used to host parish and village events.

Update – July 2022

Since our last update the orchard has been completed and a number of shrub beds have been put in place. We have also seeded the area set aside for the wildflower meadow.

We had installed four park benches prior to the grand opening on the 3rd of June which coincided with the Queen's Platinum Jubilee celebrations. There was a fantastic turnout on the day for the opening which was combined with a family day at Dobwalls Football Club.

Dobwalls Parish Council has added a couple of picnic benches for families to use at the community field and are looking to make further additions in the future.
